Conditional Agreement:

1. Proposal does not include Washington State Sales Tax.
2. Proposal is based on Blue Print estimates and is subject to actual measurements which could increase the proposal.
3. Proposal does not include preparatory work such as nailing, leveling, scraping, removal of furniture or carpet, unless acknowledged above and charges are made to prepare the work area.
4. J-Lee Floors will not be responsible for installation failures caused by lack of heat, excessive moisture conditions and/or failure caused by defective subfloors and underlayments which include improper nailing of same. For hardwood installations, J-Lee Floors will not be responsible for imperfections in subfloors and will not guarantee flooring against cupping, buckling, or shrinking of material.
5. The Builder or Owner is to turn the job over to J-Lee Floors broom clean and furnish sufficient electrical current to operate all power tools which includes 220v current for hardwood installations for operating floor equipment such as sanders and edgers.
6. Buyer agrees to pay J-Lee Floors within the time stated and as per terms and conditions stated below. In the event that payment is not made upon these terms and conditions and it becomes necessary for J-Lee Floors to place this claim with an attorney for collection or if in the event of litigation an attorney shall be employed at any stage of the proceedings to enforce J-Lee Floor's rights, Buyer agrees to pay all attorney's fees and costs to J-Lee Floors.
7. Our proposal is subject to written acceptance by Buyer and returned to J-Lee Floors within 30 days. If work is unable to proceed within 30 days of acceptance any increase in material or labor costs will be added to Proposal/ Contract price.
8. All payments are due J-Lee Floors EOM 10 days and interest at the rate of 1% per month will be added to past due accounts.
9. Any controversy or claim arising out of or relating to this contract or any breach thereof, shall be settled in accordance with the arbitration tribunal of the BETTER BUSINESS BUREAU.

Account Agreement:

The undersigned, "Purchaser", and J-Lee Floors, Inc. agree as follows:

All invoices must be paid in full by the 10th of the month following billing. If suit is brought to collect any money due on the account, Purchaser shall pay the cost of collection, including a reasonable attorney's fee, plus 1 1/2% per month interest. Purchaser has been advised as to construction Lien laws. Where J-Lee Floors, Inc executes this agreement with a corporation, the corporate officer signing on behalf of the corporation agrees to personally guarantee the indebtedness and to pay any unpaid indebtedness. Purchaser has read the terms and conditions of this agreement.
